A non-refundable deposit of \$400.00 is payable upon booking the mare with the remainder of the balance payable upon confirmation of mares pregnancy unless otherwise arranged.

The parties to this contract understand and accept the following terms and conditions prior to shipment of semen.

The mare owner certifies that said veterinarian practices equine reproduction as a regular part of his/her practice, is available for palpation, cultures, other necessary procedures, and has consented to oversee breeding of said Mare on a regular basis. The Mare owner agrees to the following conditions:

- A. The designated veterinarian must examine the mare and certify that the mare is free of infection and in good breeding condition.
- B. The provisions of the above must be repeated for any mare failing to settle within two cycles after shipment has commenced.
- C. The designated veterinarian must examine the mare for pregnancy between 15-20 days after last breeding and convey results to stallion owner.
- D. Failure to conform with the terms and conditions will nullify this contract and all guarantees shall be become null and void.

Stallion Manager: Karen Burr ridge (Peterson and Smith Reproduction Clinic, Ocala, Florida)

Frozen semen:

Please check with stallion station regarding costs of shipping frozen semen prior to mare's ovulation. All parties agree that semen shipped under this contract will be used only for inseminating the mare named above. This contract shall not be assigned or transferred to another mare without consent of the Stallion Owner.

Should the above-named mare prove to be barren, abort, or should the foal be unable to stand and nurse, provided a certificate signed by a licensed veterinarian so stating supplied to the Stallion Owner within 72 hours of the foal's death or such determination, the Stallion Owner has the option to:

- A. Rebreed the mare the following season under the same contract: or
- B. Accept a substitute mare under the same terms and conditions of the same contract.

The Stallion Owner assumes responsibility only to deliver live or frozen semen in viable condition at the time of delivery to the Mare Owner's farm or designated mare station. The designated veterinarian must administer the semen promptly on the day of delivery or upon ovulation or Mare Owner shall not be considered to have fulfilled the contractual obligations, and all guarantees are null and void.

The Mare Owner understands that the mare and the resulting foal must be blood-typed by the American Morgan Horse Association (AMHA) prior to the registration of the foal and any foal conceived in any manner not complying with this contract will not be eligible for registration.

The Mare Owner shall assume all responsibility for the condition of the mare and shall bear all risk of loss or damage to the mare, whether by whatsoever, and therefore agrees to hold the Stallion Owner and/or Stallion Manager (or any person employed by or associated with the Stallion Owner and/or Manager) harmless for any and all damages associated therewith.

The breeding season will end as of July 1 unless otherwise agreed to.
